NOTICE is hereby given that the Blackburn with Darwen Borough Council, proposes to make the above Order under Section 14(1)(a) of the Road Traffic Regulation Act 1984 to allow United Utilities to carry out urgent repairs to a waste water pipe at Woolridge Playing Fields

The effect of the Order will be to prohibit any persons from using the footpath described in the Schedule below.

There is an alternative route described in the schedule below.

The Order will come into force on Thursday 19th November 2015 and shall continue in force for a period of six months or until the works are completed whichever is the earlier.

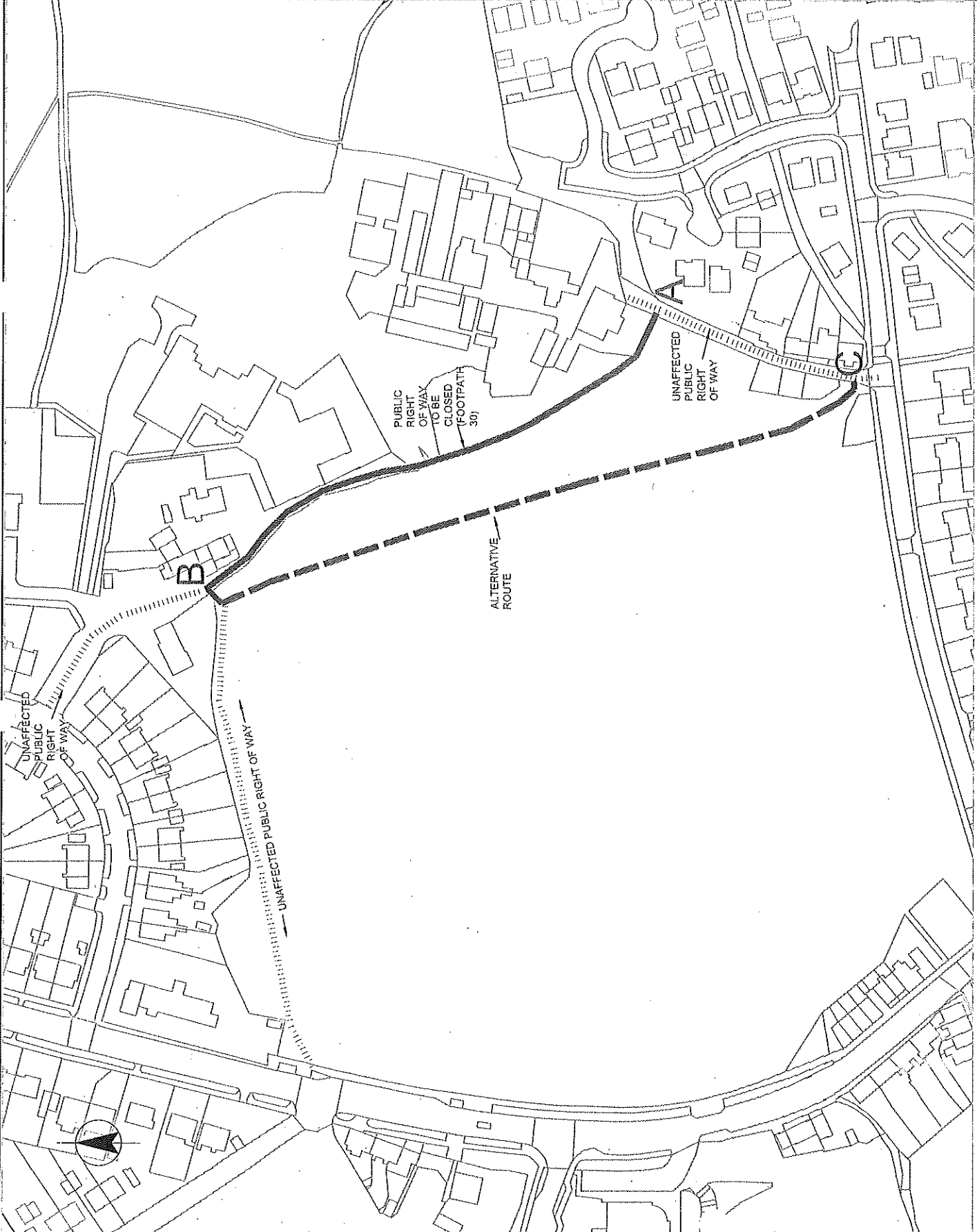
