

# Dates and Deadlines – Primary Schools

<b><u>26<sup>th</sup> May 2023</u></b> <b>Deadline for on-time appeals</b>	Appeals will be accepted after this deadline but they may be heard at a later date than appeals lodged on time
<b><u>12<sup>th</sup> June – 19<sup>th</sup> June 2023</u></b> <b>Notice of hearing information issued for appeals lodged on time</b>	For appeals lodged on time, notice of appeal hearing date and time should be issued in this time period
<b><u>26<sup>th</sup> June – 7<sup>th</sup> July 2023</u></b> <b>Appeal hearings will take place</b>	All appeals lodged before the deadline of 26 <sup>th</sup> May 2023 will take place by the end of 7 <sup>th</sup> July 2023.
<b><u>26<sup>th</sup> June 2023</u></b> <b>Notice of hearing for late appeals (VA, Free Schools and Academies)</b>	For appeals lodged after the deadline of 26 <sup>th</sup> May 2023*, notice of hearing date and time should be issued by this date wherever possible.
<b><u>w/c 10<sup>th</sup> July 2023</u></b> <b>Late appeal hearings will take place (VA, Free Schools and Academies)</b>	Hearings for appeals lodged after the deadline of the 24 <sup>th</sup> May 2022 will take place by the end of 14 <sup>th</sup> July 2023.
<b><u>3<sup>rd</sup> July 2023</u></b> <b>Notice of hearing for late appeals (LA Community)</b>	For appeals lodged after the deadline of 26 <sup>th</sup> May 2023, notice of hearing date and time should be issued by this date wherever possible.
<b><u>w/c 17<sup>th</sup> July 2023</u></b> <b>Late appeal hearings will take place (LA Community)</b>	Hearings for appeals lodged after the deadline of 26 <sup>th</sup> May 2023 will take place by the end of 21 <sup>st</sup> July 2023.
<b><u>w/c 7<sup>th</sup> August 2023</u></b> <b>School holiday appeals**</b>	Hearings for appeals lodged after the deadline of 26 <sup>th</sup> May 2023* but received before 10 <sup>th</sup> July 2022 will take place by the end of 11 <sup>th</sup> August 2023.

\*Appeal hearings for all appeals lodged after the 26<sup>th</sup> May 2023 will be heard with the on time appeals wherever possible. If they cannot be heard with the on-time appeals, they will be heard within 30 school days of the date the appeal is lodged. In some circumstances, this may mean appeals for the September intake will be heard after the school's summer holidays. We will endeavour to stick to the above dates wherever possible, however please be aware that these dates may be subject to change depending on the numbers of appeals received. Appeal hearings are heard in a hybrid format.
